## The United States Constitution

Article II, Section 1 of the U.S. Constitution imposes only three eligibility requirements on persons serving as president, based on the officeholder's age, time of residency in the U.S., and citizenship status:

## U.S. Constitution – Presidential Candidate Eligibility

"No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty-five Years, and been fourteen Years a Resident within the United States."

## SECTION 1: A DIRECT ADDRESS

My fellow Americans,

You have been told, for years, that war crimes are something *other* countries do. That the United States does not commit atrocities — only "mistakes." That the president cannot be held accountable. That a pardon is the end of the story.

**That was a lie.**

And the people who told you that lie are currently sitting in the White House, in the Pentagon, in intelligence agencies, and on the boards of banks and defense contractors. They are the ones who gave the orders. They are the ones who wrote the memos. They are the ones who transferred the money.

**They are not above the law. And you are not powerless.**

Today, I announce two things:

1. **On my first day in office — January 20, 2029 — I will sign an Executive Order** that allows the extradition of any person (current or former administration official, banker, contractor, or private actor) who has participated in war crimes, provided a foreign country issues a warrant and the UN determines war crimes are occurring.
2. **You, the American public, can direct the consequences** — right now, today — toward the current administration.

## SECTION 2: HOW YOU CAN DIRECT CONSEQUENCES

You do not need to be a lawyer. You do not need to be a diplomat. You only need to be a citizen who refuses to look away.

Here is what you can do, starting immediately:

### 1. Document and Preserve Evidence

If you are a whistleblower, a journalist, a military service member, an intelligence analyst, a contractor, or a civilian who has witnessed or has knowledge of:

- Orders that resulted in civilian deaths;
- Drone strikes outside of lawful combat zones;
- Torture or cruel treatment of detainees;
- Funding or arming of foreign militias known to commit atrocities;
- Financial transactions through U.S. banks enabling war crimes;

**Preserve everything.** Documents, emails, photos, videos, recordings, logs, financial records. Secure them outside of U.S. government networks. Share them with trusted human rights organizations (see Section 5 below).

Name names. Not anonymously — specifically.

- Which official gave the order?
- Which banker approved the transaction?
- Which contractor provided the weapons or logistics?
- Which lawyer wrote the legal opinion that retroactively justified the crime?

The Executive Order applies to **named individuals**. Your documentation can become the basis for a foreign arrest warrant.

### 3. Contact Foreign Governments

You do not need the U.S. government's permission to speak to the world.

Write to the embassies, consulates, foreign ministries, and prosecutors of countries that have been harmed by U.S. actions. Tell them:

*"I am an American citizen. I have evidence that U.S. officials committed war crimes in your country. Under the incoming administration's Executive Order, you can file charges. Here is what I know."*

Countries that have suffered — Afghanistan, Iraq, Syria, Libya, Somalia, Yemen, Palestine, and many others — have every right to seek justice. Your letter could be the first page of their case file.

### 4. Petition the United Nations

The UN must determine that war crimes are occurring for the extradition process to trigger. You can:

- Submit evidence to the UN Office of the High Commissioner for Human Rights (OHCHR).
- Petition your congressional representative (even if they are hostile) to request a UN inquiry.
- Support civil society organizations that have standing before the UN Human Rights Council.

The more public pressure, the faster the UN acts.

## 5. Support Human Rights Organizations

The following organizations have existing mechanisms to document war crimes and refer evidence to international bodies:

- Amnesty International
- Human Rights Watch
- The International Commission of Jurists
- The Center for Constitutional Rights
- Reprieve
- The Yemen Peace Project
- The Syria Justice and Accountability Centre

Donate. Volunteer. Share evidence. These organizations will become the clearinghouses for the warrants of the future.

## 6. Use Your Vote and Your Voice

The current administration (2026–2028) is on notice. Every official who remains in power between now and January 20, 2029, is accumulating exposure.

Ask them directly, in town halls, in letters, in protests:

*"If a foreign country issues a warrant for your arrest for war crimes after January 2029, will you waive extradition? Will you resign? Will you confess?"*

Their silence is evidence. Their defiance is a confession.

### **The Executive Order (EO 2029-01) will:**

- Mandate extradition for anyone (including the president, cabinet, military, bankers, contractors) when a foreign warrant exists and the UN has determined war crimes are occurring.
- Declare that presidential pardons do not block international extradition.
- Limit judicial delays to 30 days for habeas review.
- Use tax dollars to fund extraditions.

### **The Executive Order will NOT:**

- Apply retroactively to acts before January 20, 2029?  
*Yes — it applies to any warrant active on or after that date, regardless of when the crime occurred.*
- Require the current administration's consent.  
*No — it binds the executive branch on Day One of my term.*
- Protect anyone who committed crimes before 2029.  
*No. If the warrant is active on January 20, 2029, extradition proceeds.*

## **SECTION 4: A WARNING TO THE CURRENT ADMINISTRATION**

To every current official reading this letter:

You have between now and January 20, 2029 — approximately 1,009 days from the date of this letter — to consider your future.

Every order you give. Every bomb you drop. Every bank transfer you approve. Every legal memo you write that stretches the definition of "lawful" into atrocity.

All of it is evidence.

And one day, a foreign prosecutor will read it. A UN panel will cite it. A warrant will issue.
